ORDINANCE NO. 1-2023

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF LESTER, IOWA, BY AMENDING PROVISION PERTAINING TO SPECIAL SPEED ZONES ON CERTAIN STREETS AND AVENUES IN LESTER, IOWA

BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF LESTER, IOWA:

SECTION 1. SECTION MODIFIED. The Code of Ordinances of the City of Lester, Iowa, **Article 3.08 – SPECIAL SPEED ZONES** under **ARTICLE 3 - SPEED REGULATIONS** is amended by amending Subsection 2(a) which is hereby adopted as follows:

3.08 SPECIAL SPEED ZONES. A speed in excess of the limits set out miles per hour shall be unlawful on any of the following designated streets or parts thereof:

- 1. INCREASED SPEEDS:
 - a. None
- 2. LOWER SPEEDS:
 - a. 45 MPH on Dove Avenue/K30 from 140th Street south to the presently existing 25 MPH residential zone.

SECTION 2. REPEALER. All ordinances of parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 3. SEVERABILITY CLAUSE. If any section, provision, or part of this Ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the Ordinance as whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.

SECTION 4. WHEN EFFECTIVE. This Ordinance shall be in effect from and after its final passage, approval and publication as provided by law.

Discussion was held regarding 2023-24 Street Finance Report. Lance Boote made a motion to approve Resolution 2023.14 as presented. Jeff Hoogeveen seconded the motion with all members voting in favor.

Discussion was held regarding 2023-24 Financial Year End Report. Jeff Hoogeveen made a motion to approve Resolution 2023.15 as presented. Lance Boote seconded the motion with all members voting in favor.

Discussion was held regarding an application from Lester Feed & Grain for a new grain dryer and 2 grain legs for Commercial Tax Abatement. Curtis Doorneweerd made a motion to approve the application with the option 10-year sliding scale beginning with 80% tax abatement and ending with 20% abatement of the actual value. Lance Boote seconded the motion with all members voting in favor.

Discussion was held regarding an application from Lester Feed & Grain for new grain leg tower, conveyors and overhead ingredient bins for Commercial Tax Abatement. Jeff Hoogeveen made a motion to approve the application with the option 10-year sliding scale beginning with 80% tax abatement and ending with 20% abatement of the actual value. Curtis Doorneweerd seconded the motion with all members voting in favor.

Dwight Mogler discussed with the council an option for the flood plain land recently acquired on the east side of Meadowview. Jeff Hoogeveen made a motion to approve planting wildflower grass seed. Erika Kellenberger seconded the motion with all members voting in favor.

Alliant Energy representatives attended the meeting and extended their apologies for the length of time the city experienced due to a wire being accidentally cut outside of town causing an electrical outage. The crew that responded to the outage was not familiar with the service feed coming into Lester, causing the extended time for repair, the representatives have reassured the council that this issue has been resolved.

Discussion was held regarding the City of Lester welcome sign on Hastings, the north side of the sign currently sells advertising space to local businesses for a 2-year contract. Council members discussed adjusting the rate to \$25/year. Any local business interested in advertising may contact any council member for additional information.

Discussion was held regarding the renewal of the traffic logix speed radar on Highway 9 on the east side of Lester. Curtis Doorneweerd made a motion to approve a 3-year extension for \$1,200. Erika Kellenberger seconded the motion with all members voting in favor.

Discussion was held regarding the removal of the "No Outlet" sign from Meadowview Drive and installing it on Depot Street to eliminate traffic attempting to use that street to access the ball diamond.

Discussion was held regarding installing a "Children at Play" sign on Meadowview Drive to control traffic speed with the street now being extended with the addition.

Discussion was held regarding an additional school bus stop on Meadowview Drive to accommodate the increased number of children in that neighborhood and eliminate the safety concern of the children currently crossing the highway to access the current bus stop on Main Street. The mayor will contact the school superintendent to address the concern of council members.

The next regular city council meeting will be Monday, November 6, 2023, at 6:30 PM at the Lester City Council Chambers.
