At the meeting of the City Council of Lester, Iowa, held on the 5th day of June 2023, the following Resolution was proposed and unanimously adopted: Curtis Doorneweerd made a motion to approve the resolution. Erika Kellenberger seconded the motion with all members voting in favor.

WHEREAS, a proposed Dedication and Plat of the Meadowview Second Addition to the City of Lester, Lyon County, Iowa, has been submitted to the City for review by Lester Development Corporation, an Iowa Nonprofit Corporation, and the City of Lester, an Iowa Municipal Corporation, being the owners and proprietors of the real estate described on the said Plat.

WHEREAS, the City has found that the Plat does conform with the requirements of Chapter 354 and 355 of the Code of Iowa and conforms with the City's Comprehensive Plan and it is in the best interests of the public to approve the Plat.

WHEREAS, the City hereby accepts and approves the Dedication to the public of all lands within the Plat that are designated for streets.

THEREFORE, BE IT RESOLVED, that the City of Lester, Iowa, hereby approves and accepts the Plat designated as the MEADOWVIEW SECOND ADDITION to the City of Lester, Iowa.

BE IT FURTHER RESOLVED, that the City hereby accepts and approves the Dedication to the public of all lands within the Plat that are designated for streets.

The Mayor and the City Clerk are hereby directed to furnish to Lester Development Corporation and the City of Lester a certified copy of this Resolution as required by Iowa law.
