Quit Claim Deed for the utility easement on Meadowview (Res. 2025-3) has been filed.

A City/School election will be held on November 4th, 2025. City candidates may find nomination papers at the DRG office in Lester. Filing begins on Monday, August 25th, 2025, and ends on Thursday, September 18th, 2025.

Bryan Phillips applied for a building permit to construct a fence. Curtis Doorneweerd motioned to approve the building permit. Jeff Hoogeveen seconded the motion; all members present voted in favor.

After discussion about increasing water and sewer rates, the council instructed city clerk to draft an ordinance that will increase the city's water and sewer rates to \$3.25 per 1,000 gallons of water used by residents.

Jeff Hoogeveen motioned to set a Public Hearing for Sewer & Water Rate Increases (Res. 2025.04) on August 4th, 2025, 6:00PM, at the Lester Community Center. Erika Kellenberger seconded the motion; all members present voted in favor.

Lester Local submitted a retail permit application for Cigarette/Tobacco/Nicotine/Vapor. Curtis Doorneweerd motioned to approve the permit. Jeff Hoogeveen seconded the motion; all members present voted in favor.

Lester Visioning provided a brief update that the walking path has been completed from the bank to the creek. Curb and gutter work are being completed at the West End of Depot Street.

The Park's department is determining the best location in the city park to pour a concrete slab large enough for placement of up to three picnic tables.

The Community Center department shared that the fitness center has a new treadmill installed and ready for use by members. An older treadmill will be posted for sale on Facebook through a closed bid process. Bids can be made by contacting Dan at DRG.

The Street's Department reported that there are a few portions of city streets in need of patching. The council is committed to having a plan in place before winter.

The next regular city council meeting will be held on Monday, August 4th, 6:15PM, at the Lester City Council Chambers following the Public Hearing at 6:00PM.

Kurtis Myrlie made a motion to adjourn the meeting. Lance Boote seconded the motion; all members present voted in favor.
