Discussion was held regarding the upcoming 2023-2024 City Budget. Curtis Doorneweerd made a motion to set a Budget Hearing for March 6, 2023 at 6:30 PM. Erika Kellenberger seconded the motion with all members voting in favor.

Discussion was held regarding Building Permit 2023-163 application from Wyhe's Choice Fundraising to remodel the first floor classrooms to office space inside the existing building located at 205 5th Street. Jeff Hoogeveen made a motion to approve the building permit. Erika Kellenberger seconded the motion with all members voting in favor.

Discussion was held regarding Building Permit 2023-164 application from Dutchland Frozen Foods to construct a 45' x 28' Morton building addition to south side of the existing building on Hastings Street for use as shipping and receiving, including 2 dock bays. Curtis Doorneweerd made a motion to approve the building permit. Erika Kellenberger seconded the motion with all members voting in favor.

Lester Development updated the city with the progress of the covenants and land purchase finalization for the residential lot additions on the north end of Meadowview Drive. Council members were provided copies of the proposed 28E Agreement to review before next council meeting.

Mowing applications for the 2023 season are due on March 6th at the council meeting.

Discussion was held in regards to an option available to upgrade the Community Center gym floor, Jeff Hoogeveen presented to the council members present, information from Kiefer USA, including samples and quotes to replace the current concrete to rubber flooring. Council will need to table this discussion to explore options to fund this project.
