Public Notice is hereby given that the Council of the City of Lester, Iowa, will hold a public hearing on the 4th day of December 2023 at 6:30 P.M., in the Lester Community Center, Lester, Iowa, at which meeting the Council will vacate the alleyway described as:

The South half (1/2) of the alleyway lying adjacent to and directly North of Lots Four (4), Five (5), Six (6), Seven (7), Eight (8), Nine (9), Ten (10), Eleven (11), Twelve (12), Thirteen (13), Fourteen (14), and Fifteen (15), in Block Seven (7), of the Town (now City) of Lester, Lyon County, Iowa.

The North half (1/2) of the alleyway lying adjacent to and directly South of Lots Two (2), Three (3), and Sixteen (16), in Block Seven (7), of the Town (now City) of Lester, Lyon County, Iowa.

Discussion was held regarding Lester Local, LLC renewal application for a Liquor License. Jeff Hoogeveen made a motion to approve the application. Curtis Doorneweerd seconded the motion with all members voting in favor.
Lester Development Corp update was provided to the council members, the concrete work is complete for the streets, electrical and communication lines are being installed. Next meeting LDC will be the discussing the placement of the streetlights in the development. Council members will review the current street lights within the city and discuss lighting needs at the next council meeting
Discussion was regarding the city being awarded a grant from the Lyon County Riverboat Foundation for funds to update the Community Center gym flooring project. The renovations have been scheduled for January 22-30, 2024, during this time the Community Center will not be available for rent or gym use. During this shutdown, we will take advantage of this time and give the walls a fresh coat of paint.
Discussion was held regarding the CALL Lions 4H club plan to enclose the current park shelter building as a community improvement project, they also plan to build a bus stop shelter for the bus stop location on Meadowview, as soon as the West Lyon School District has approved the addition of the bus stop location.
Lester Winterfest is scheduled for Thursday, December 7 th at Lester Community Center.
The next regular city council meeting will be Monday, December 4, 2023, at 6:30 PM at the Lester City Council Chambers.
